Checklist of materials to be submitted by the municipality to the Conservation Review Board (CRB)

Proceedings under section 31(5) of the *Ontario Heritage Act*

Objection to a Notice of Intention to repeal a designating by-law or part of a designating by-law

The municipality must provide the following documents/information to the CRB before the hearing process can begin. Please provide only **one** copy of each document, numbered and labelled in the order outlined below.

1. Objection

- A copy of the Notice(s) of Objection.

2. Affidavit

- Affidavit by the municipality confirming:
 1. the legal ownership on title of the property (with the Parcel Register report);
 2. the Notice of Intention to repeal the by-law (or part of the by-law) was served on the legal owner(s) of the property and on the Ontario Heritage Trust, with the date of service and a copy of the document(s) served;
 3. the Notice of Intention to repeal the by-law (or part of the by-law) was given public notice in accordance with the *Ontario Heritage Act* (the Act), with a copy of the newspaper notice displaying the name of the publication and the notice date; and,
 4. the Notice(s) of Objection was filed within 30 days after the Notice of Intention to repeal the by-law (or part of the by-law) was published in a newspaper.

3. By-law

- A copy of the by-law that designated the property under section 29 of the *Ontario Heritage Act*, including the statement of cultural heritage value or interest and a description of the heritage attributes of the property.

4. Report

- Any staff reports used to draft the statement of cultural heritage value or interest of the property.
- Any staff reports prepared in relation to the intention to repeal the designating by-law (or part of the by-law).

5. Minutes

- An excerpt of the Council/Committee meeting minutes related to the municipality's intention to repeal the designating by-law (or part of the by-law).

6. Legal description

- The legal description of the subject property.

7. List

- A list of all parties and their legal representatives, including their mailing address, telephone number and e-mail address.
- A list of any other persons that have requested to be notified of this matter, including their mailing address (and telephone number and email address, if available).

8. Other information

- Any other documents or information relevant to this matter.
